The total number of sections taken together for classes XI and XII should not be more than 1/3 of total number of section allowed. Further, increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per Affiliation Bye Laws and subject to the availability of room size of greater than 500 sq ft.			
2	The school has constructed aramp at a side entrance without a hand rail. No ramp is seen at the entry of the main building which is against the principle of inclusive education. The school has overlaid a wooden temporary ramp over stair case which is steep and not as per norms. The school shall affix a hand rail along the ramp at the ground floor, construct a ramp at the main entrance of the school, dismantle the wooden ramp and construct a ramp/install a lift as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.			
3	The school has put temporary signage on one of the regular cubicles in the washrooms and put a temporary seat on WC. This is not as per norms and hence unacceptable. The general washrooms are congested, dirty and need maintainece. The school while maintaining sanitary conditions in general washrooms shall construct separate toilets for CWSN, boys and girls on every floor, with permanent signage, indicating the floor number as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.			
4	The school building safety certificate refers to G+1 floor, which seems to be the new building(in white) only. The school shall get a combined building safety certificate for both the blocks. Similarly it shall get a fire safety certificate covering both the blocks. The school shall submit these certificates on SARAS within 3 months and upload them on mandatory disclosure section of the website as compliance.			
5	Failure to submit compliance for the above mentioned points within prescribed time shall invite financial penalty against the school.			
6	The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from YouTube.			
7	The school shall conduct training of its teachers with CoE Pune within 3 months and submit the compliance.			
8	The school is advised to follow the SoPs issued by the Board in respect of labs, library and sports facilities.			
9	The school shall get all the mandatory certificates renewed periodically.
